

Last Tuesday, the 2nd, was Candlemas day, the day on which, according to the Germans, the Groundhog peeps out of his winter quarters and if he sees his shadow he pops back for another six weeks nap, but if the day be cloudy he remains out, as the weather is to be moderate.

In Scotland the tradition may also derive from an English poem:

As the light grows longer  
The cold grows stronger  
If Candlemas be fair and bright  
Winter will have another flight  
If Candlemas be cloud and rain  
Winter will be gone and not come again  
A farmer should on Candlemas day  
Have half his corn and half his hay  
On Candlemas day if thorns hang a drop  
You can be sure of a good pea crop

In Alaska, February 2 is observed as Marmot Day rather than Groundhog Day because few groundhogs exist in the state. The holiday was created by a bill passed by the Alaska Legislature in 2009 and signed by then-Governor Sarah Palin that year.

## Motions

### **OUSU Post Motion - Proposed by JB**

OUSU has the facility to accept mail for OUSGG and keep it for one of us to pick up. This would save us having to change the addresses on accounts, insurance and similar things every year. In the past, changing the addresses has been a lot of hassle and has caused problems. Only one person can collect the mail from OUSU.

It is proposed we ask OUSU to accept our mail for us, and that we change the addresses to the OUSU offices.

RO: How much does it cost? JB: It is free

EH: Would we be able to collect mail during the vacation

JB: We can collect mail during office hours, but I don't know if that includes during the vacation. JB to find out.

It was agreed that the job of collecting mail should be associated with a committee position. Secretary, Membership Secretary and Treasurer were proposed as possible positions, and the general consensus was that it should be the role of the Secretary.

Voted to postpone motion until TGM so that JB could find out whether we will be able to receive mail during the vacations, and so that a constitutional amendment can be submitted that requires the secretary to check the OUSU offices for mail regularly.

### **Savings Account Motion - Proposed by MB**

We need to change the signatories on the Savings Account as none of the current signatories are current members. The Secretary and Treasurer need to be signatories, and we can have up to two extra signatories. Three witnesses are needed to change the signatories.

It was agreed to sign the form now, but postpone submitting it until we have sorted out sending post to OUSU.
